this report provides suggestions for overall improvement in delivery of police services for greater protection against crime the national advisory commission on criminal justice standards and goals considers the patrolman the primary force in reducing and preventing crime and thus directs its report recommendations toward increasing police effectiveness suggestions for improvements in police functions are presented in the areas of community planning and organization technology and support services fiscal management and coordination with other criminal justice agencies these proposals appear in the form of more than 120 specific standards and recommendations that spell out where why and how these improvements can and should be made in the police segment of the criminal justice system report on police is a reference work for the practitioner patrolman to police chief as well as for the interested layman before implementing any of the changes advocated police departments are

advised to detail the legal limits of police authority and develop guidelines for the exercise of that authority in order to improve cooperation between the police and the community it is suggested that police agencies establish a specialized unit for maintaining communication with citizens each police department should encourage and participate in neighborhood security programs and establish procedures to facilitate processing of complaints suggestions for more effective utilization of manpower include continued consolidation stricter personnel requirements increased employee benefits and the employment of more women minorities and civilians in police work

public administration as an american profession originated in the early twentieth century with urban reformers advocating the application of scientific and business practices to rehabilitate corrupt city governments that approach transformed governance in the united states but also guaranteed recurrent debate over the proper role of public administrators who must balance the often contradictory demands of efficiency and politically defined notions of the public good currently the business approach holds sway legitimated by al gore s national performance review the new public management movement promotes entrepreneurs over civil servants performance over process decentralization over centralization and flexibility over rules john rohr demurs arguing that the movement goes too far in downplaying the distinctively american challenges arising from the separated powers principle consequently the npm alienates public management from its natural home a nation state established within a constitutional order according to rohr nothing is more fundamental to governance than a constitution and therefore to stress the constitutional character of administration is to establish the proper role of administration as governance that includes management but transcends it as well this is not a novel argument for rohr who was recognized in 1999 by the louis brownlow committee of the national academy of public administration for his lifetime contributions on the constitutional underpinnings of public administration but this new version of his rule of law critique directly addresses the npm s excesses framed convincingly as a comparative study of cases found in four countries spanning three centuries as a result rohr establishes that the constitutional administrative nexus is intimate stable pervasive and enduring the first half of the book examines the linkages between constitutions and administrations in france the united kingdom and canada all of them sufficiently similar to the united states to make comparisons meaningful and sufficiently different to provide illuminating perspectives on domestic practices the examples extend from the french revolution through the founding of the canadian confederation in the 1860s to such contemporary issues as the influence of administrative directives from brussels on the british courts the second half of the book examines american cases in three categories separation of powers individual rights and federalism in each case rohr highlights instances of public management with all its warts and wrinkles tending to the mundane details of translating great constitutional principles into everyday actions american administrative law rohr concludes has structured safeguards to protect the integrity of administrative decision making while also holding it accountable constitutional law has helped establish civil servants freedom of speech and applied the fundamental principles of federalism to the administrative process he summarizes his findings from the case studies by saying that the constitutional role of american civil servants comes not only from specific american experiences but also from the very nature of civil service

they were foot soldiers and officers they served in the regular army and the waffen ss and remarkably they were also jewish at least as defined by hitler s infamous race laws pursuing the thread he first unraveled in hitler s jewish soldiers bryan rigg takes a closer look at the experiences of wehrmacht soldiers who were classified as jewish in this long awaited companion volume he presents interviews with twenty one of these men whose stories are both fascinating and disturbing as many as 150 000 jews and partial jews or mischlinge served often with distinction in the german military during world

war ii the men interviewed for this volume portray a wide range of experiences some came from military families some had been raised christian revealing in vivid detail how they fought for a government that robbed them of their rights and sent their relatives to extermination camps yet most continued to serve since resistance would have cost them their lives and they mistakenly hoped that by their service they could protect themselves and their families the interviews recount the nature and extent of their dilemma the divided loyalties under which many toiled during the nazi years and afterward and their sobering reflections on religion and the holocaust including what they knew about it at the time rigg relates each individual s experiences following the establishment of hitler s race laws shifting between vivid scenes of combat and the increasingly threatening situation on the home front for these men and their family members their stories reveal the constant tension in their lives how some tried to hide their identities and how a few were even aryanized as part of hitler's effort to retain reliable soldiers including field marshal erhard milch three star general helmut wilberg and naval commander bernhard rogge chilling compelling almost beyond belief these stories depict crises of conscience under the most stressful circumstances lives of hitler s jewish soldiers deepens our understanding of the complex intersection of nazi race laws and german military service both before and during world war ii
